CODE OF CONDUCT FOR CANDIDATES FOR THE ELECTION TO DYAL SINGH EVENING COLLEGE STUDENTS' UNION AND CENTRAL COUNCIL OF DELHI UNIVERSITY STUDENTS' UNION 2025-26

- No candidate, after the withdrawal date is over, will be allowed to contest for two posts. If a candidate
 does not withdraw and his/her name appears against two posts his/her candidature will stand cancelled
 from both the posts and the candidate will have no right to protest.
- No posters shall be used by the candidates or pasted within the premises of the College. College walls shall not be disfigured. Involving in any such activity will lead to strict disciplinary action. Only handmade cards should be distributed.
- 3. No candidates shall invite or involve outsiders in the Elections.
- 4. No candidates shall use amplifier or loudspeaker for the election propaganda inside the College Campus.
- There will be no canvassing in the Class Rooms, inside College corridors & building and teaching in the Class Rooms will also not be disturbed.
- 6. No pressure or intimidation shall be exercised in promoting one's candidature.
- Sectional appeal shall not be made by any candidate. Personal allegations and derogatory remarks shall be avoided.
- 8. Use of musical instruments and other media or entertainment i.e. Bhangra and Beating of Drums shall not be undertaken in the College premises.
- 9. The candidates shall not use the name or prestige of any teacher in promoting his candidature.
- 10. No non-student should enter the campus of the College.
- 11. No candidates or any student will protest if any candidate is debarred from contesting the elections if he/she violates the code of conduct.
- 12. The candidate should have passed all the papers in the last examinations and in no case should have any Academic Arrear(s) and should have minimum 75% attendance.
- 13. The candidate should know that the elections are to be held strictly on the basis of Lyngdoh Committee recommendations.
