

### **1.0 Background:**

Faculty of College were conducted ICSSR project of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) scheme. The PMKVY emerged as a flagship initiative of the Indian government aimed at addressing the skill gap and enhancing employability. Launched in 2015, PMKVY has undergone several phases, evolving in response to changing needs and priorities. The year 2020 witnessed the introduction of the New Education Policy, which placed renewed emphasis on mainstreaming vocational education and introducing Lok Vidya. This policy shift reflects a growing recognition of the need to equip individuals with practical skills and prepare them for the demands of the modern workforce.

To monitor PMKVY Scheme in various cities of Haryana, Western Uttar Pradesh and Uttarakhand, under ICSSR project. It is planned to carried out the field survey work in various district of Haryana, Western Uttar Pradesh and Uttarakhand in the project (Annexure I).

#### **4.0 Qualification criteria**

The minimum qualification criteria are as under and the proposal not meeting these criteria shall be rejected:

1. The firm should be NGO/NPO organization.
2. The firm should have experience in providing similar procurement services to Central/ State Government PSUs and other Government organizations.
3. The firm should have successfully completed projects related to procurement in the last 05 years, as given below: -
  - a) Three similar works, each of value not less than 01 lakhs  
or
  - b) Two similar works, each of value not less than 02 lakhs,  
or
  - c) One similar work of value not less than 05.00 lakhs.
4. The firm should not be blacklisted by any Central/State Govt./PSU/Govt. bodies(self-declaration in their letter head).
5. Copy of PAN and GST registration number of the firm.
6. The firm should have adequate infrastructure and qualified team/professional (minimum 05 numbers) for executing the project. The details may be furnished.

The signed and scanned copy of documentary evidence in respect of above should be uploaded along with the proposal of EOI.

#### **5.0 Mode of Evaluation/Screening**

1. Screening of EOIs shall be carried out as per the qualification criteria and verification of documents, submitted by the firm.
2. Qualified firms will be provided a brief note about the ICSSR project and the firm may be asked to make a presentation before the selection committee showcasing their proposal.
3. EOI will be evaluated for short listing inter-alia, considering their past experience/performance of handling similar type of project, manpower strength, financial strength of firm and presentation / proposal to the selection committee.

4. The screening of the EOI shall be undertaken based on the following criteria:

IV.	Technical capability (adequate infrastructure and team)	10 marks
V.	Technical interaction/presentation by the firm	10 marks

This would help in assessing the depth which the scheme has achieved on ground. This will help us in assessing the inclusivity and social welfare that the scheme has achieved for backward classes. The generated data sets would help in preparing the evaluation framework which would then be considered to assess the trainees, that are the beneficiaries and the training providers, trainers.
