1.0 Background:

Dyal Singh Evening College under the University of Delhi, Govt. of India. One of the functions is carried out research project. Faculty of College were conducted ICSSR project of The Swachh Bharat Mission (SBM) scheme. The Swachh Bharat Mission (SBM), initiated in 2014, adopted a comprehensive approach by integrating supply-driven policies such as the government-sponsored construction of Individual Household Latrines (IHHL) and demand-creation policies like Information, Education, and Communication (IEC) to instigate positive changes in people's behavioural patterns. It is crucial to undertake a qualitative examination of the characteristics and delivery mechanisms of SBM to comprehend the interplay between the policy framework and its success rate. Furthermore, a more significant inquiry involves conducting an empirical assessment of the socio-economic impact of SBM, necessitating an extensive quantitative study across diverse regions. This approach enables the derivation of pertinent insights related to the effectiveness of SBM.

The study attempts to examine the unique socio-economic landscapes of the selected states in the context of the policy challenges in the implementation of SBA and its impact on diverse communities. The proposed research examines not only the progress in infrastructure related to the sanitation practices but also takes into account the campaign's broader effects on economic development, public health outcomes, and social dynamics. By juxtaposing the strategies and outcomes in Uttar Pradesh, Bihar, Odisha, and Madhya Pradesh, the proposed study contributes valuable insights into the campaign's efficacy in distinct socio-economic contexts. 2.0 Aims & Objectives:

The objective is to avail Services from a firm for providing consultancy services for carry out field survey work of the project under the Project.

3.1 Submission of EOI Proposal

- d) The proposal will be opened as per as the date/time as mentioned in the EoI critical date sheet. The result of qualifying proposals will be update on email.

4.1 Qualification criteria

The minimum qualification criteria are as under and the proposal not meeting these criteria shall be rejected:

1. The firm should be NGO/NPO organization.
2. The firm should have experience in providing similar procurement services to Central/ State Government PSUs and other Government organizations.
3. The firm should have successfully completed projects related to procurement in the last 05 years, as given below: -
 - a) Three similar works, each of value not less than 01 lakhs
 - or
 - b) Two similar works, each of value not less than 02 lakhs,
 - or
 - c) One similar work of value not less than 05.00 lakhs.
4. The firm should not be blacklisted by any Central/State Govt./PSU/Govt. bodies(self-declaration in their letter head).
5. Copy of PAN and GST registration number of the firm.
6. The firm should have adequate infrastructure and qualified team/professional (minimum 05 numbers) for executing the project. The details may be furnished.

The signed and scanned copy of documentary evidence in respect of above should be uploaded along with the proposal of EOI.

5.0 Mode of Evaluation/Screening

1. Screening of EOIs shall be carried out as per the qualification criteria and verification of documents, submitted by the firm.
2. Qualified firms will be provided a brief note about the ICSSR project and the firm may be asked to make a presentation before the selection committee showcasing their proposal.
3. EOI will be evaluated for short listing inter-alia, considering their past experience/performance of handling similar type of project, manpower strength, financial strength of firm and presentation / proposal to the selection committee.
4. The screening of the EOI shall be undertaken based on the following criteria:

I.	Experience in similar work in past years	60 marks
II.	Work undertaken	10 marks
III.	Financial soundness of the firm and turnover	10 marks
IV.	Technical capability (adequate infrastructure and team)	10 marks
V.	Technical interaction/presentation by the firm	10 marks

- Parameters of implementation of SBM resulted in reduction of Diseases.

It is pertinent to build and create a database which consists of socio-economic profile representing marginalised classes. This would help in assessing the depth which the scheme has achieved on ground. This will help us in assessing the inclusivity and social welfare that the scheme has achieved for backward classes. The parameters pertaining to the quality of skill training would help in assessing the criteria on which grading of training institutes is done. The generated data sets would help in preparing the evaluation framework which would then be considered to assess the trainees, that are the beneficiaries and the training providers, trainers.
